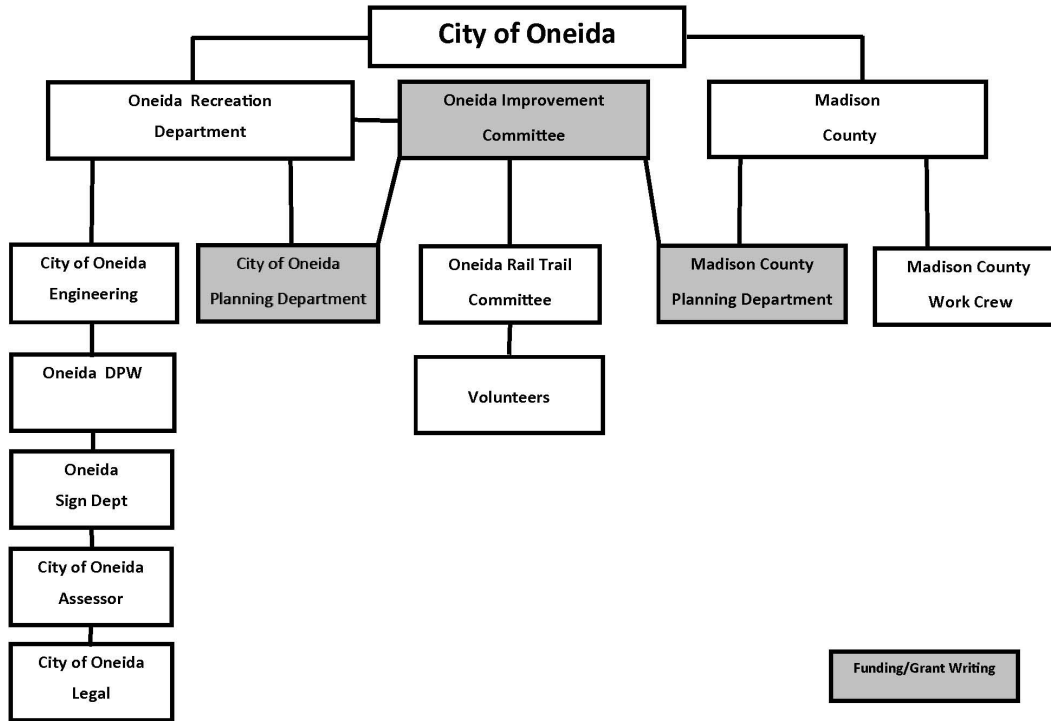

2013 was a year when we saw the vision of the Oneida Rail Trail take shape. It started with momentum from the votes from our community resulting in the winning of Central New York Community Foundation's CNY85 grant. \$8,500 went to the Oneida Improvement Committee, Inc. who is the not for profit partner of the Oneida Rail Trail. There was no looking back. The Oneida Rail Trail Committee was then formed. Members selected for this committee have many positive attributes to see the ORT project through to completion. Experience, passion, commitment, and humor are all positives that are relied upon from our committee members.

Businesses have come on board seeing the potential for the ORT to bring economic development to a community hungry for it. One of those businesses who saw the potential was NuTech Biosciences who donated two properties to be used for the ORT project. Volunteers have been sought and added to a database that receives updates on upcoming trail days and invites to ORT meetings. Several people have come forward using their individual expertise to move this project forward. 1 mile of the ORT was cleared on National Trails Day in June with the help of some of these volunteers. We will continue to seek those volunteers to ensure the ORT will be maintained for years to come.

Members of the ORT committee spent many hours sharing the concept of the ORT with a powerpoint presentation. Several organizations hosted us at their monthly meetings and luncheons during 2013. We were pleasantly surprised with a generous donation from the Ralph & JoAnn Stevens Fund which is administered by the CNY Community Foundation. Dr. Stevens attend one of those presentations. As we continued to educate people on the ORT, this local community project quickly attracted the attention of regional and state organizations and officials.

The ORT was recognized in our Region's Sustainability Plan (Vision CNY) as a project to watch in 2014. Parks & Trails New York (PTNY) selected the City of Oneida to host the Bicyclists Bring Business workshop in October. This workshop and bike-a-round brought out people and businesses from several surrounding counties to take part in determining how to attract bicycle tourists to their communities from the Erie Canalway Trail. PTNY was particularly interested in the side trip Erie Canal tourists could take along the Oneida Rail Trail and continue to take an active role in helping the project.

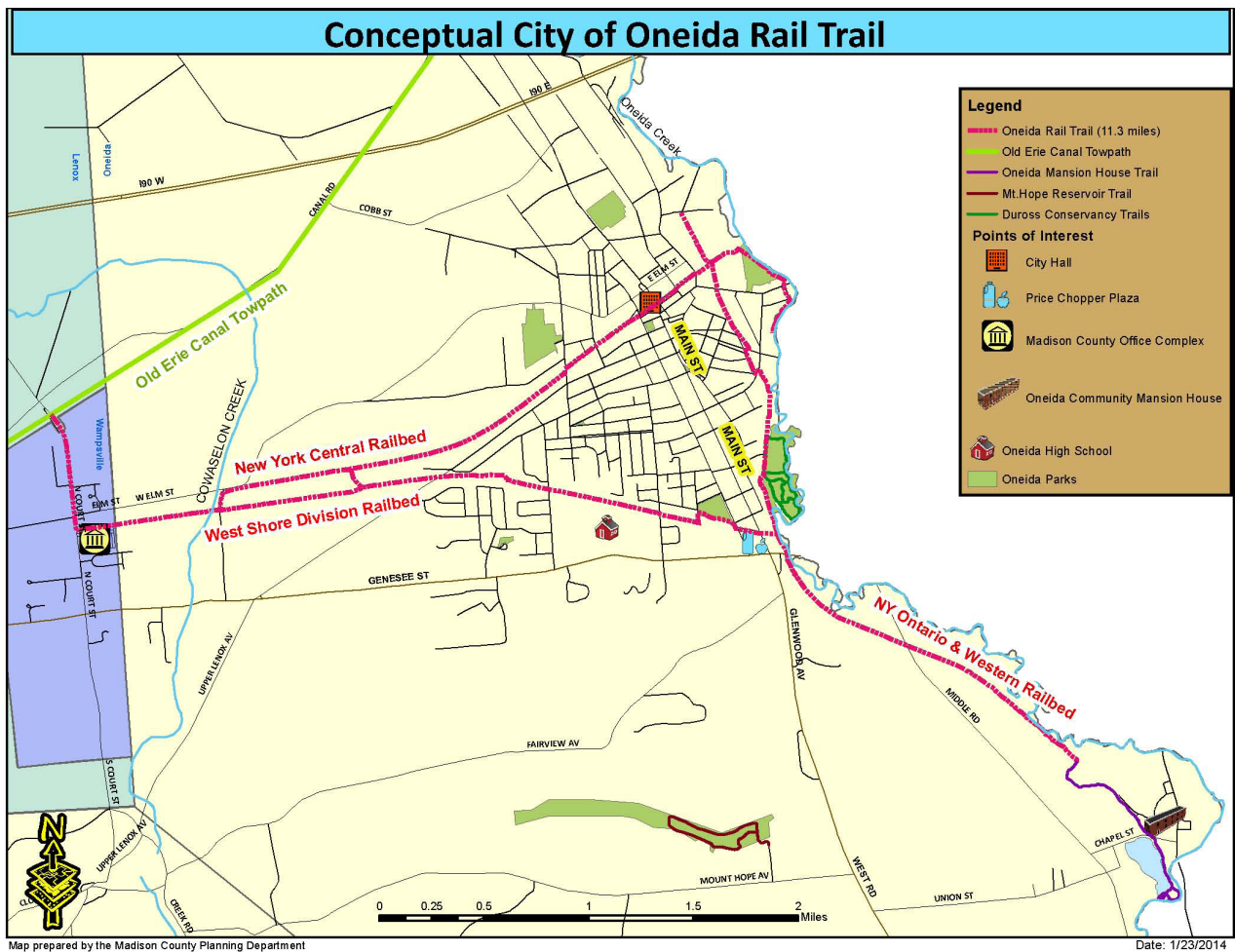
Our local officials have been very supportive of the Oneida Rail Trail project. The City of Oneida partnered with the Madison County Planning Department to submit an application to the NYS DOT Transportation Enhancement Program (TEP). The application was successful in securing close to \$550,000 to construct a fully handicapped accessible 3.1 mile segment of the Oneida Rail Trail from the Erie Canal Trailhead in Wampsville to N. Willow Street in Oneida.

The ORT Committee will continue to seek out funding and grants to provide cost savings for this highly anticipated project. The ORT Committee will continue to work on outreach and building awareness to cultivate even more partnerships for the project. 2014 proves to be a challenging and exciting year for the Oneida Rail Trail. We look forward to a day when the City of Oneida can boast they have a state of the art multi-use trail system that encompasses their city.

The Oneida Rail Trail is a proposed 11.3-mile non-motorized, multi-use trail located in the City of Oneida. The Oneida Rail Trail (ORT) will preserve and utilize existing rail beds (no tracks remain) to create a cultural corridor along three former rail lines: the New York Central, West Shore Division, and New York Ontario & Western. These former rail beds run through the heart of downtown Oneida and connect to the Village of Wampsville to the west and the City of Sherrill to the southeast.

Through the use of these rail beds, the Oneida Rail Trail will link three communities, multiple neighborhoods, businesses, offices, parks, tourist destinations, education facilities, and other trails including the Old Erie Canal Towpath to create a new economic engine in the area and source of community pride.

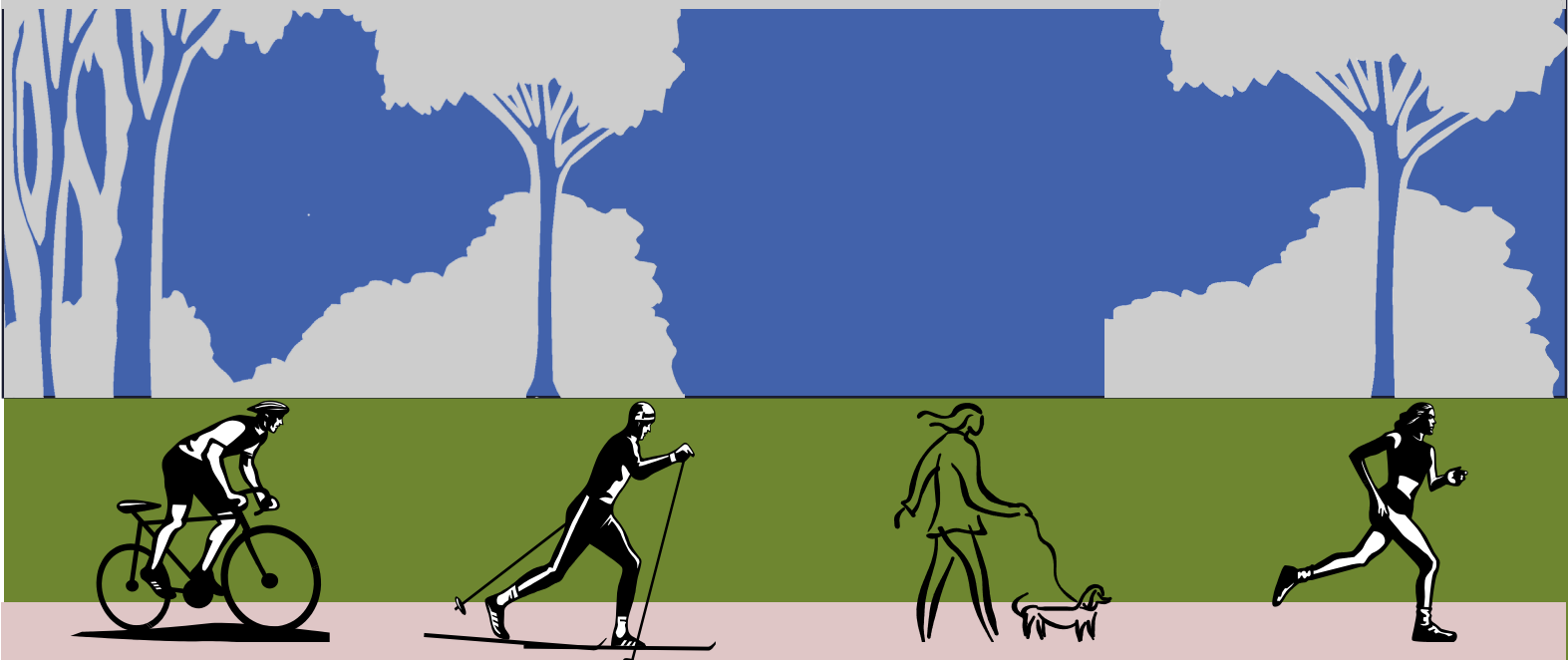
The ORT is an identified project in the City of Oneida’s current Comprehensive Plan with the goal to “formerly designate the railroad right-of-ways as greenways and initiate implementation of trail system.” The City of Oneida owns the majority of the properties that make up the trail and much of the proposed project area is already being used by the community as an unofficial trail.

One of the unique features of the ORT project is that because it involves three intersecting railbeds it is not just an out and back trail but instead will offer the option for a 5.7 mile loop.

The ORT Committee was created to lead the effort to transform this historic asset into an official City trail system and into the envisioned resource desired by the community.

**Joe Magliocca** grew up in Oneida and has biked the rail beds throughout Oneida for most of his life. He is also the President of the Oneida Improvement Committee.



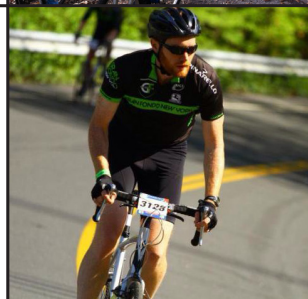
**Jim Chamberlain** is the Ward 5 Councilman for the City of Oneida.

# ORT Wins \$8,500 Grant

January 2013 - The Oneida Rail Trail project was announced the winner of an \$8,500 grant from the Central New York (CNY) Community Foundation.

As part of its 85th Anniversary, the CNY Community Foundation created the CNY85 Giving Project to award (4) \$8,500 grants over four rounds. The CNY85 grant was unique because it was based only on public voting: the project to receive the most public votes (in each of the 4 rounds) would receive an \$8,500 grant.

As a 501-3C, the Oneida Improvement Committee was able to enter the Oneida Rail Trail project into the 4th round which focused on "Arts, Culture, Recreation & Civic Engagement." A total of 27 projects from Madison and Onondaga County entered this 4th round.

Public voting was open December 1-31st. Individuals could vote once every day.

After the first day of voting the ORT was only in 6th place, but then an incredible momentum started to build. Over the course of the month, word started to spread and more and more of the community got behind the project. Local businesses, like Pepi's, were distributing flyers and community members were reminding each other to vote everyday through Facebook and e-mail.

After a very exciting build up, the Oneida community voted the ORT to the #1 spot! Out of 27 projects, the Oneida project earned about 12,500 votes to come out on top and win the \$8,500 grant!

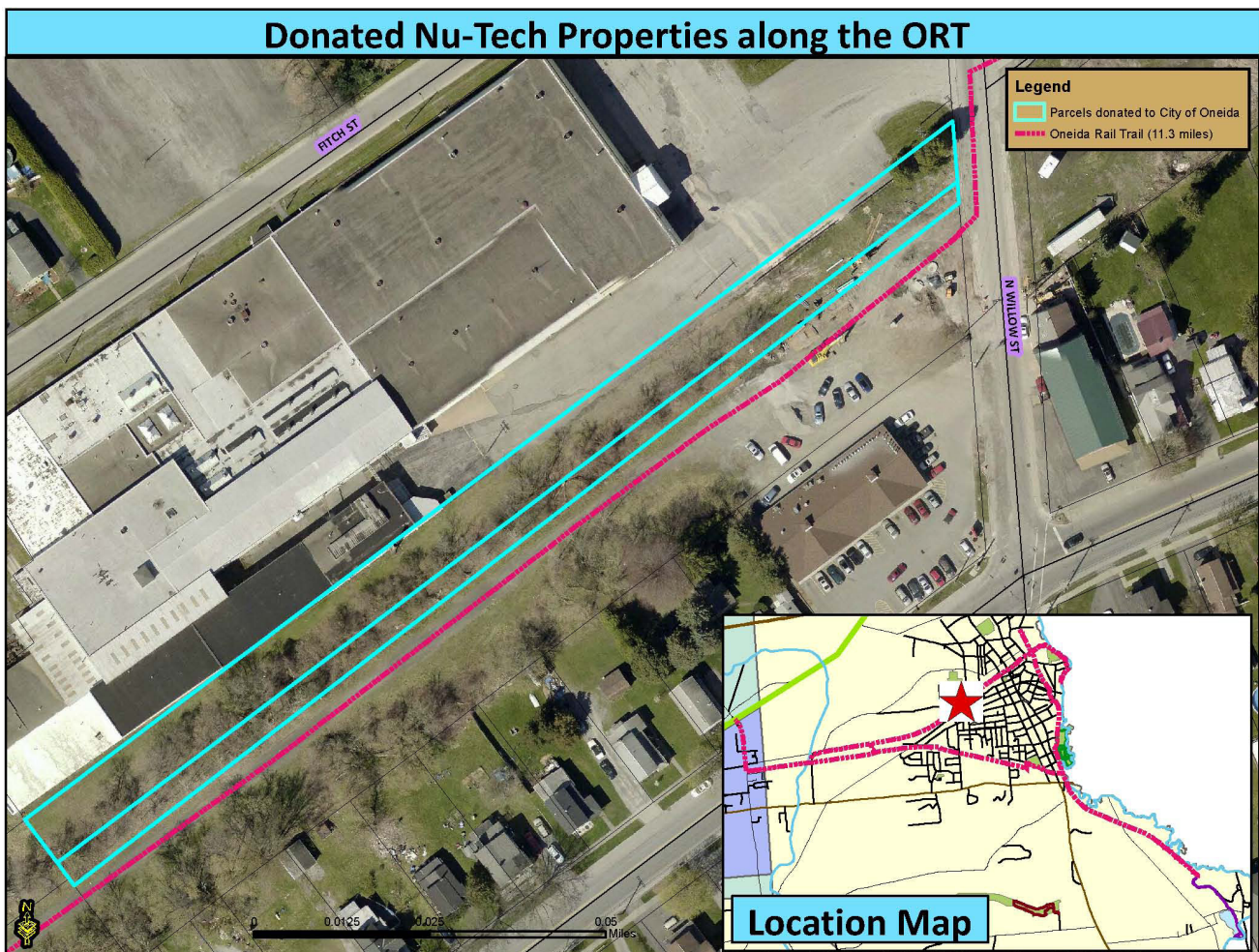
The 2 currently vacant properties are located on the west side of N. Willow Street and total approximately 1.13 acres.

# NYS DOT TEP Award

August 2013 - The City of Oneida partnered with Madison County to submit an application to the NYS DOT Transportation Enhancement Program for a 3.1 mile section of the ORT.

This 3.1 mile segment of the ORT extends from N. Willow St in Oneida along the NY Central Railbed and will connect northwest through Wampsville to the NYS Erie Canalway trail.

Proposed improvements include a fully handicapped accessible stone dust trail, restoration of a historic rail bridge, trailheads, and signage. See rendering below.

Prior to construction, design work and environmental review will have to be complete. NYS DOT states it is usually two years between TEP funding approval and the start of construction.

## Background on TEP

The Transportation Enhancement Program (TEP) is a federal reimbursement program administered in New York by NYS DOT.

TEP funding is dedicated for strategic investments in non-motorized transportation alternatives. The intent of the program is to encourage tourism and economic development opportunities Statewide. The funds cover up to 80 percent of the cost of a project, with the remaining 20 percent or more coming from the project sponsor.

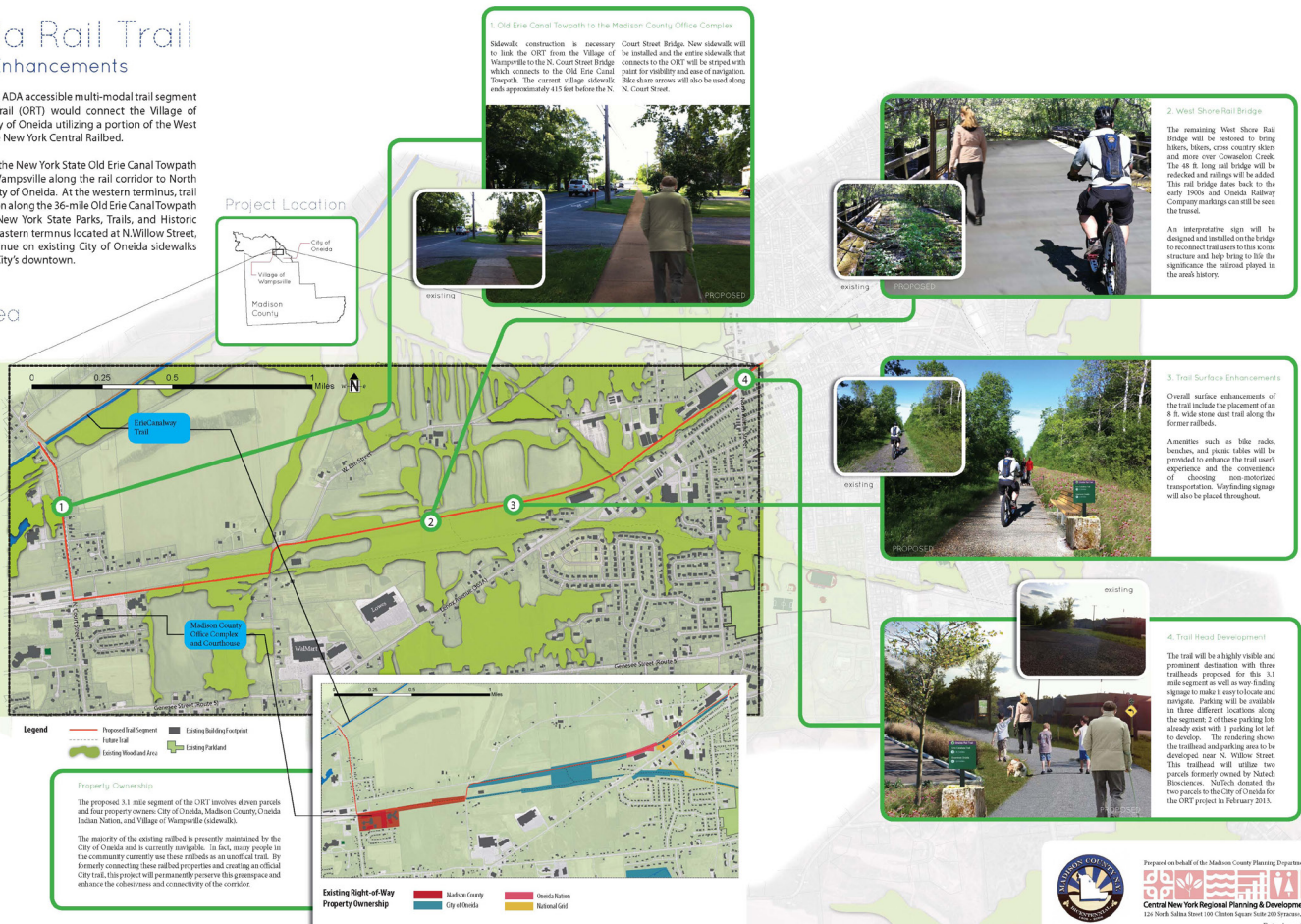
**UPDATE:** January 2014 - The City of Oneida's application was successful! *The ORT was 1 of only 63 projects statewide to be selected and will receive \$545,830 for the development of this 3.1 mile segment.*

## Oneida Rail Trail Proposed Enhancements

The proposed 3.1 mile ADA accessible multi-modal trail segment of the Oneida Rail Trail (ORT) would connect the Village of Wampsville to the City of Oneida utilizing a portion of the West Shore Railbed and the New York Central Railbed.

The segment will link the New York State Old Erie Canal Towpath to the northwest of Wampsville along the rail corridor to North Willow Street in the City of Oneida. At the western terminus, trail users could continue on along the 36-mile Old Erie Canal Towpath Trail maintained by New York State Parks, Trails, and Historic Preservation. At the eastern terminus located at N. Willow Street, trail users could continue on existing City of Oneida sidewalks and directly into the City's downtown.

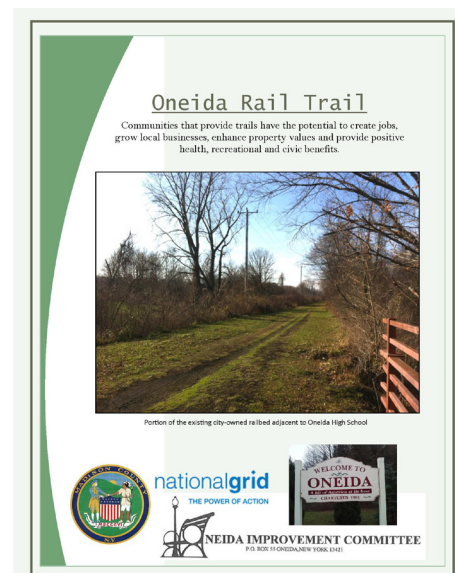
## Thanks to the support and generosity of community members like you the Oneida Rail Trail will come to fruition.

Through the B3 Workshop, Parks & Trails NY provided free technical assistance to help our local business owners, elected officials, local tourism industry, and those in charge of local land use decisions discover what services, amenities, and street designs make a difference to bicyclists when choosing a touring destination.

Based on information gathered during the two day workshop, Parks & Trails NY developed a Final Report with 7 recommendations to help Oneida better attract and profit from the growing bicycle tourism market. The ORT was identified as “the most desirable” type of trail bicycling tourists are seeking.

- Work with the OIC to develop a website to house info on the ORT
- Develop an ORT logo
- Work with the City to officially open the section of the ORT from Hubbard Place to Lenox Ave
- Develop an Action Plan to prioritize tasks
- Continue to seek out grants and fundraising opportunities
- Continue to educate the community on the project through public presentations and promotional materials
- Schedule and advertise community clean-up events along the ORT
- Organize public walks/rides along currently open sections of the ORT
- Develop a West Shore Railbed Corridor Study to describe ownership, unique features, and existing conditions (similar to the document created for the NY Central Railbed)
- Develop a NY Ontario & Western Railbed Corridor Study to describe ownership, unique features, and existing (similar to the document created for the NY Central Railbed)
- Open an ORT display in Oneida Commons for Railroad History/ORT products
- Explore the feasibility of holding a Railroad/Trail Show at Kallet
- Work with the City of Oneida to help implement the NYS DOT TEP grant for the 3.1 mile section of the ORT extending from N. Willow St in Oneida to the Old Erie Canalway Trailhead in Wampsville.



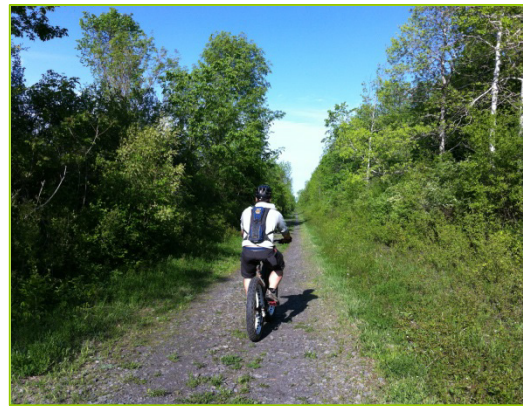
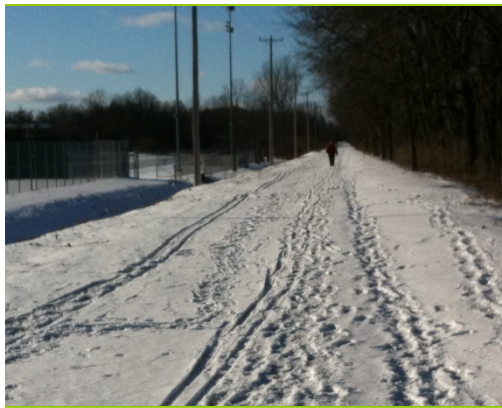
